Dear Camp Ohana-Nash Parents and Guardians,

Welcome to Ohana-Nash Summer Camp at the Boys & Girls Club of Greater Nashua! We are elated that your family has chosen our Camp to serve your child for this year's summer vacation! Ohana-Nash Summer Camp is available for children between 4th and 6th grade. We are committed to providing a safe, inclusive and fun environment for our Campers. We are excited to welcome campers back and to meet new friendly faces. We are aiming for our best summer yet!

Every day, your child would be provided breakfast, lunch and snack. Your child will participate in weekly themed programming in our Clubhouse games room, gym, dance studio, art room, education room and indoor swimming pool. Ohana-Nash Summer Camp will use public and wooded areas adjacent to the Boys & Girls Club of Greater Nashua including the Ledge Street Elementary playground, baseball fields and Mines Falls trails. Every camp week; on Wednesday or Friday depending on your child's camp cohort assignment, your child will attend an off-site field trip, weather permitting. Morning and evening transportation will be available to any Camper in need of transportation to and from Ohana-Nash Summer Camp. Bus stops are identified from select locations throughout Nashua. A separate permission slip is required for Campers using our transportation services.

Included in this registration packet are all of the necessary forms to complete your child's registration for Camp. Registration and deposits will be necessary to reserve your child's space each week. The cost of Ohana-Nash Summer Camp is \$125 per week. For any family registering more than one child for the same camp week, a sibling discount of 10% will be applied. Payment for each week of Camp must be paid in full before the first day of the Camp week.

Ohana-Nash Summer Camp operates on Monday through Friday from 8:30am until 5:30pm.

Early Bird (Before-Camp Care) Option Available!

Monday through Friday from 7:00am-8:30am - \$25/week per child

For families in need to additional hours of care, we offer our Early Bird Program! For an additional \$25 per week, parents can bring drop their child off to camp as early as 7:00am! Registration for the Early Bird program is required prior to the camper being dropped off to camp.

Parent/Guardian Consents and Agreements

Please read each statement thoroughly. Please initial and sign all highlighted areas.

I understand that the Boys & Girls Club of Greater Nashua expects all campers to abide by a set of appropriate rules designed to protect the safety and enjoyment of all campers. When necessary, the Boys & Girls Club of Greater Nashua reserves the right to suspend a camper from immediate or future attendance. Suspensions due to Club member behavior will result in forfeiture of all paid current weekly fees.

Payment refunds, credits or transfers must be made at least one week prior to the start of the camp session. If a camper cancels 21 days prior to camp, a full refund may be given. If canceling 14 days or more prior to camp, a \$15 administrative fee will be assessed per camper. If canceling less than seven days prior to the start of the camp week, no refund will be given. No refunds or credits will be given after the camp week has started. Please be advised that there will be no refund for missed days.

Credit Card, Debit Card, Personal check, cash and money order will be accepted for camp payments. Initial registration must be done in person. A \$20.00 fee will be assessed on all returned checks. Parents should keep receipts on file, as the Boys & Girls Club of Greater Nashua does not prepare year-end statements of fees paid.

Camp Ohana-Nash is a state-licensed summer camp program for youth ages 8-18 years old designed to provide afterschool program opportunities in three core program areas; academic success, good character & citizenship, and healthy lifestyles. The license exempt program will occur at the Boys & Girls Club facility at One Positive Place, as well as other collaborative program locations. I understand that the program is not a license child care program and children participating in the program have the right to come and go from the program and that employees will encourage, but cannot force, children to stay.

I give consent for any photographs or video in which my child may appear to be used in any way that Club staff may care to use them.

I understand the rules of the Club and request that my child be admitted into membership. I have explained the rules to my child and understand that the Club will not be responsible for any accident to my child on the premises or while engaged in any of its activities aware from the Club.
