# 2024 Ohana-Nash Summer Camp Program Policies

## Behavior Expectations

I understand that the Boys & Girls Club of Greater Nashua expects all campers to abide by a set of appropriate rules designed to protect the safety and enjoyment of all campers. When necessary, the Boys & Girls Club of Greater Nashua reserves the right to suspend a camper from immediate or future attendance. Suspensions due to Club member behavior will result in forfeiture of all paid current weekly fees.

## Technology Policy

I understand that the Boys & Girls Club of Greater Nashua prohibits the use of personal devices (cell phones, laptops, etc.) in Early Learning Center and Clubhouse program areas. In the Teen Center, the use of personal devices (gaming, etc.) is prohibited, though cell phone use is allowed in designated areas.

## Late Fee Policy

I understand that the Boys & Girls Club of Greater Nashua Summer Camp Program closes at 5:30 PM. Parents/guardians who arrive to pick up their member(s) after this time will be charged a late fee of \$25. This charge will be added to your Brightwheel account balance and must be paid within 2 weeks.

## Group Change Policy

I understand that the Boys & Girls Club of Greater Nashua will place my child(ren) in a cohort group based on the grade they are entering. I understand that I may not request that my child be moved to a different group. I understand that due to fluctuations in enrollment, my child(ren) may not remain in the same group throughout the summer, though staff will work to keep their cohort assignment the same.

Camp Ohana-Nash is a state-licensed summer camp program for youth ages 8-18 years old designed to provide afterschool program opportunities in three core program areas: academic success, good character & citizenship, and healthy lifestyles. The license exempt program will occur at the Boys & Girls Club facility at One Positive Place, as well as other collaborative program locations. I understand that the program is not a licensed childcare program and children participating in the program have the right to come and go from the program and that employees will encourage, but cannot force, children to stay.

I understand the rules of the Club and request that my child be admitted into membership. I have explained the rules to my child and understand that the Club will not be responsible for any accident to my child on the premises or while engaged in any of its activities aware from the Club.

# 2024 Ohana-Nash Summer Camp Parent/Guardian Financial Responsibility

Please read each statement thoroughly. Please initial and sign all highlighted areas.

I understand that I will be invoiced for Camp on Fridays. Payments are due by 6PM Monday for the following camp week. Payments made after Monday at 6PM will result in a late fee of \$15 on your Brightwheel account. IE: Week 1 (6/24) payment is due on (6/17). Invoice will appear in Brightwheel on 6/14.

I understand that if a payment is not made the Friday before reserved camp week, along with any late fees, the reserved camp week and full deposit will be forfeited.

I understand that Camp Ohana-Nash requires a two week written notice to the Camp Director, or administrative staff, in order to cancel a registered week of summer camp. If the Club does not receive a two-week notice, a \$50 administrative fee will be assessed per camper to your Brightwheel account.

Credit Card, Debit Card, personal check, cash and money order will be accepted for camp payments. A \$20.00 fee will be assessed on all returned checks. Parents should keep receipts on file, as the Boys & Girls Club of Greater Nashua does not prepare year-end statements of fees paid.

## Financial Aid

The Boys & Girls Club of Greater Nashua partners with the Department of Education Rekindling Curiosity summer camp assistance program. This financial assistance is approved on a first come first serve basis.

Eligible students and corresponding youth recreation aid includes:

- Students with a disability are eligible for up to \$750
- Students from families at or below 250% federal poverty level are eligible for up to \$600
- Students from families at or below 400% federal poverty level are eligible for up to \$450

The Boys & Girls Club of Greater Nashua utilizes the Brightwheel™ App for Summer Camp billing, as well as for communications regarding weekly information, field trips, and other updates. The App is free of charge, and is highly encouraged! All Summer Camp payments and balances may be made within the App.
